- All services are provided at no cost to the patient but Rennie Grove relies on the generosity of the local community to help it raise 87% of the £7.9 million it costs to fund the service every year £20,000 each day.
- Rennie Grove works with other healthcare providers, such as GPs, District Nurses and other hospices to ensure co-ordinated care and a seamless service.
- Rennie Grove has 27 shops that raised £2.8 million in 2017-18.
- Rennie Grove relies on the support and expertise of over 1,500 regular and part-time volunteers. We
  estimate that the value of the hours given by our volunteers is approximately £1.5 million each year.
  Our volunteers were honoured to receive the Queen's Award for Voluntary Service in 2017, the MBE for
  volunteer groups.
- Rennie Grove's children's Hospice at Home team is also supported by the Pepper Foundation.
